1. CALL TO ORDER / PLEDGE OF ALLEGIANCE / ROLL CALL

At 6:04 p.m., Chairman Fenne called to order the March 18, 2021 Regular Meeting of the College of DuPage Board of Trustees. Chairman Fenne led the Pledge of Allegiance.

5. REPORTS

a. Chairman's Report

c. <u>President's Report</u>

Dr. Caputo reported on the following:

Forbes Recognizes COD as Top Midsized Employer

College of DuPage has been named to Forbes Magazine's prestigious list of

America's Best Midsized Employers for 2021, ranking second among community colleges, 17th in the education category and 292nd overall.

Forbes partnered with market research firm Statista to compile the list by surveying 50,000 Americans working for businesses with at least 1,000 employees. Participants were asked to rate their willingness to recommend their own employers to friends and family, and to nominate organizations other than their own.

The ranking is divided into two lists: one for large companies with more than 5,000 U.S. employees and another for midsize companies with 1,000 to 5,000 employees. COD employs approximately 3,000 faculty and staff members.

The college's recognition reflects the dedication of faculty and staff to help students achieve their goals and create a culture of caring throughout the entire institution.

College of DuPage has received the prestigious designation of being a Military Friendly School for 2021-2022.

Institutions earning the Military Friendly® School designation were evaluated using both public data sources and responses from a proprietary survey. Over 1,200 schools participated in the 2021-2022 survey with around 750 schools earning the designation of which 162 selected for the "Gold" award status for their leading practices, outcomes, and effective programs.

The McAninch Arts Center has been selected as a 2021 Honoree for the Daily Herald Business Ledger's Annual Awards for Business Excellence. The MAC was nominated by the DuPage Convention & Visitors Bureau. The awards were presented during a virtual event held earlier today at 4 p.m.

The Daily Herald Business Ledger Annual Awards for Business Excellence (AABE) highlight successful suburban businesses and organizations and honor the people who make them successful.

The AABEs, given for business achievement, growth and community involvement, are presented to outstanding businesses and non-profit organizations with a significant presence in the suburban circulation area of the Daily Herald Business Ledger (DuPage County, Fox Valley, Northwest Cook County, Lake County, West Cook County, Southwest Cook County and Will County.)

General Updates:

Illinois Council of Community College Presidents has drafted a letter to

- petition Gov. JB Pritzker to include front-line community college employees in the state's 1-B Group vaccination schedule
- Received an update on state budget issues. The Illinois Board of Higher Education has recommended a 2% increase in state funding for community colleges. ICCTA is collaborating with the Illinois Council of Community College Presidents to advocate for a larger funding increase than the 2 percent included in the Illinois Board of Higher Education's Fiscal Year 2022 request
- Were informed that ICCTA is applying for a grant from the Joyce Foundation to research and collect data on the state's need for community college baccalaureate degrees
- Noted that April is Community College Month. ICCTA has requested an official proclamation from the Governor's office and will feature Illinoisrelated #CCMonth stories on social media.

Trustee Roundable Discussion:

- 1. What are your colleges doing to promote vendor diversification?
- 2. COVID how are your colleges dealing with unions and meeting student needs?
- 3. How have students been doing with almost total e-learning? Are you going back to in person classes and when? If so at what percentage would be in person compared to pre-covid?
