<sup>2</sup> Incomplete FA Payment Plans may be available for students with outstanding financial aid paperwork requiring the students' attention. Students who enroll in the Incomplete FA Payment Plans after May 31 will have a down payment of 10% of their student account balance.

\*The **\$15 enrollment fee** will be assessed to the student's account only in the event an outstanding balance exists on the first scheduled payment date.

\*\*The **\$5 down payment** is required at the time of enrollment in order to verify the checking/savings account or debit/credit card provided.
